

**ПОСТРАДЯНСЬКА СХІДНА ЄВРОПА.
ДОСЯГНЕННЯ ПОЛІТИЧНОГО РОЗВИТКУ СХІДНОЄВРОПЕЙСЬКИХ НАРОДІВ
У 1991–2020**

Резюме: Цю статтю присвячено оцінюванню політичного розвитку шести пострадянських країн Східної Європи та шести невизнаних державних утворень, які існують у цьому ж регіоні. Після майже тридцяти років державотворення ці країни стали засадничими частинами нового європейського регіону — пострадянської Східної Європи.

Використовуючи сучасні бази даних щодо розвитку політичних систем та режимів, автор вимірює та демонструє різноманітність і спільність розвитку регіону. Автор, зокрема, доводить, що сподівання початку 1990-х років на демократичне та процвітаюче майбутнє не були вповні досягнуті у розвитку пострадянських східноєвропейських держав. Натомість сьогодні цей регіон складається з набору напіввільних та невільних країн, а також невільних самопроголошених державних утворень, суперечності між якими, ймовірно, приведуть до майбутніх конфліктів.
