

## ПРИРОДА ЗБРОЙНОГО КОНФЛІКТУ НА ДОНБАСІ: ПОСТНЕКЛАСИЧНИЙ ПОГЛЯД<sup>1</sup>

**Анотація.** У статті, крізь призму постнекласичної методології, досліджено збройний конфлікт на Донбасі, як похідна Української кризи. Автор критично аналізує три основні підходи до вивчення, і, відповідно, три рівні пізнання природи зазначеного конфлікту: неореалістичний, політико-режимний та культурний. Виходячи з постнекласичного світобачення та фрактального розуміння дихотомії Схід — Захід, історично, лінгвістично і культурно різноманітна Україна, зокрема Донбас, розглядаються як континуум фрактальних відмінностей та опозицій від національного до місцевого рівнів. У статті запропоновано політичні та інституційні шляхи врегулювання збройного конфлікту на Донбасі в контексті сучасних тенденцій глобалізації. Автор висновує, що конфлікт не може бути вирішений доти, доки Україна не досягне певного балансу (динамічного й мінливого в просторі) між Заходом і Сходом. У статті розглядається інклюзивна модель безпеки для Європи і Євразії. Автор обґрунтовує, чому Україна може мати вирішальне значення для успіху трансконтинентального діалогу Азія — Європа.
